

TERMS AND CONDITIONS

3. In case of need, the driver has to be changed within 24 hours of being informed.
4. In case of repair and maintenance, a similar car shall have to be provided by the supplier.
5. Payment of hiring charges will be on monthly basis against bill raised by the supplier supported by appropriated signature of logbook from the user.
6. Tax will be deducted from the bill as per rules.
7. The duty area of vehicle will be generally within Agartala and its suburb. But as per requirement it shall be required to perform its duty in other parts of the State involving night stay. In case of emergency, the vehicle may be used on holiday(s) also.
8. No enhancement of rates within the validity period of the contract shall be entertained.
