Offers received after due date and time will not be considered. ~~8~~ Successful quotationers are liable to supply the feed ingredients that shall be ordered from time to time within 7 (seven) days from the date of receipt of the orders.

The rate of Rice Bran should be offered for F.O.R. Gomati Cattle Feed Plant located in the R.K. Nagar Farm Complex, Agartala, West Tripura inclusive of all and this rate should be valid for the period of supply as indicated above. No price hike will be allowed during the quoted period. Unloading and staking cost of the ingredients at our go-down should be at supplier cost. No extra terms/clause will be entertained if found in the rates of the quotationer.

The supply of ingredients shall be accepted on **gross weight basis**. Cost of the feed ingredients should be paid only after the feed ingredients are tested in the Government Feed Analytical Laboratory at Abhoynagar (D.I. Lab). The samples of such feed ingredients should be taken on random sampling at Gomati Feed Mixing Plant at R.K. Nagar which will be sent subsequently to the Government Feed Analytical Laboratory at Abhoynagar (D.I. Lab) for its testing. No penal interest/ claim will be entertained for delayed payment.
