Terms and Conditions

- 1. Payment terms No advance payment will be made. Payment would be made after receipt of materials in Good and Safe Condition at GCMPUL and GST bill.
- 2. Quoted rate should be valid for 1 (one) year from the date of submission of quotation.
- 3. Rate should be FOR Agartala Dairy inclusive all taxes etc. Unloading cost of the materials at our go-down should be at supplier cost.
- The consignment should not have manufactured before August 2024 and with one year expiry period from date of Manufactured.
- 5. The total consignment should supply in 100 gm bottle (i.e. 360 nos of bottle) and combine with Vitamin A & D Premix should have water soluble.
- 6. If any broken/damage/less quantity Premix bottle fund supplier should liable to replace same Quantity of premix at his own cost to GCMPUL.
- 7. The successful supplier should have submit a complete test report of Vitamin A & D Premix from any NABL accreditation Laboratory with the supplied consignment.
- 8. The quantity may increase or decrease.
